

International Waldenstrom's Macroglobulinemia Foundation (IWMF) Travel & Lodging Assistance Program

What is the purpose of this program?

Having a rare diagnosis is difficult. Adding in the cost of numerous consults and the complex care required to diagnose and manage it, makes a rare disease even harder.

Thanks to funding from the IWMF, this program will help lessen the financial burden on people affected by Waldenstrom's macroglobulinemia.



The IWMF Travel & Lodging Assistance Program provides individuals diagnosed with Waldenstrom's macroglobulinemia (WM) financial assistance for travel and lodging to WM medical consults and appointments, as well as for travel related to clinical trial eligibility screening or first clinical trial visit (not being paid for by trial sponsor) up to the program's established financial limit.



Who is eligible for this program?

You must meet all of the following criteria to be eligible:

- Have a confirmed diagnosis, or be under evaluation for WM.
- Have a scheduled WM related medical appointment with a healthcare provider and provide verification of appointment documentation **or**
- Have a scheduled clinical trial screening visit or first study visit scheduled with clinical trial/study site.
- Be a United States citizen or permanent resident; in many cases, residents from outside the U.S. may be eligible.
- Meet the program's financial eligibility criteria.

What is the application process?

Individuals may be referred to the program by their healthcare provider, their case managers, or they may self-refer.

Applications may be completed over the phone, by email or online through NORD's website.

A NORD Patient Services Representative will guide the applicant through the application process, and verify eligibility for inclusion in the program.

Awards are based on meeting eligibility criteria and funding availability, and are made on a first-come, first served basis.

How does this program assist?

NORD will book and prepay travel and lodging costs for the eligible individual's WM-related medical appointment/consult or study screening visit.

• A NORD Patient Services Representative will review with you eligibility, covered expenses and award amount limits.

Expenses may include:

• Round trip economy class airfare for the patient and up to one traveling companion.

• Hotel accommodations for up to two nights.

• A flat rate reimbursement of \$200 to cover expenses related to mileage, tolls and parking, if a personal vehicle is used for transportation for the eligible appointment.
